THIS IS NOTICE THAT AN ANNEXATION PETITION HAS BEEN FILED WITH FRUIT EHIGHTS CITY.

YOU ARE RECEIVING THIS NOTICE AS THE RECORDED OWNER OF ONE OR MORE PARCEL(S) IN OR WITHIN A ½ MILE RADIUS OF THE AREA PROPOSED FOR ANNEXATION.

The Fruit Heights City Council received notice of certification of the "Samuel G Raymond Inc. Annexation" Petition ("Petition") on October 12, 2021 and may grant the Petition and annex the area described in the Petition unless, in accordance with UCA § 10-2-407(2)(a)(i), a written protest is filed with the Davis County Commission and a copy of the protest delivered to the Fruit Heights City Recorder. THE AREA PROPOSED FOR ANNEXATION IN THE PETITION IS ATTACHED HERETO AND INCLUDED WITH THIS NOTICE.

The area proposed for annexation into Fruit Heights City will also automatically be annexed into the Kaysville City Fire Department and Davis County Sherriff's Office to provide fire protection, paramedic, emergency services, and law enforcement services.

PROTESTS

PROTESTS SHALL BE FILED IN ACCORDANCE WITH THE REQUIREMENTS IN UCA § 10-2-407.

In accordance with UCA § 10-2-407(1), a protest to the Petition may be filed by:

- a. The legislative body or governing board of an affected entity; or
- b. An owner of rural real property (as defined in <u>UCA § 17B-2a-1107</u> as an area zoned primarily for manufacturing, commercial, or agricultural purposes and that does not include residential units with a density greater than one unit per acre.)
