

WATERING SCHEDULES VARY IN FRUIT HEIGHTS CITY

Depending where you live in Fruit Heights, your home receives secondary water from one of four sources: Hights Creek Irrigation, Benchland Water, Weber Basin Water, or Fruit Heights City. Each source has imposed restrictions to make the limited water last as long as possible.

Restrictions may change, and vary depending on provider. See map below to determine who provides secondary water to your home.

HAIGHTS CREEK

1. TWO days/week watering
2. Water based on home address:
 - Address ending in 0, 1, 2, 3 irrigate Monday & Thursday
 - Address ending in 4, 5, 6 irrigate Tuesday & Friday
 - Address ending in 7, 8, 9 irrigate Wednesday & Saturday
3. No hosing down sidewalks/driveways
4. Limit new landscaping

BENCHLAND WATER

1. ONE day/week watering* (**)
2. NO irrigation use on weekends
3. Limit new landscaping
4. One day a week hand watering trees/shrubs
5. No hosing down sidewalks/driveways

WEBER BASIN WATER

1. ONE day/week watering**
2. Water based on home address:
 - Address ending in 0 or 2 irrigate Monday
 - Address ending in 1 or 3 irrigate Tuesday
 - Address ending in 4 or 6 irrigate Wednesday
 - Address ending in 5 or 7 irrigate Thursday
 - Address ending in 8 or 9 irrigate Friday
3. No hosing down sidewalks/driveways
4. Limit new landscaping
5. Violation fees
 - 1st violation - Given notice
 - 2nd violation - \$250.00 fee

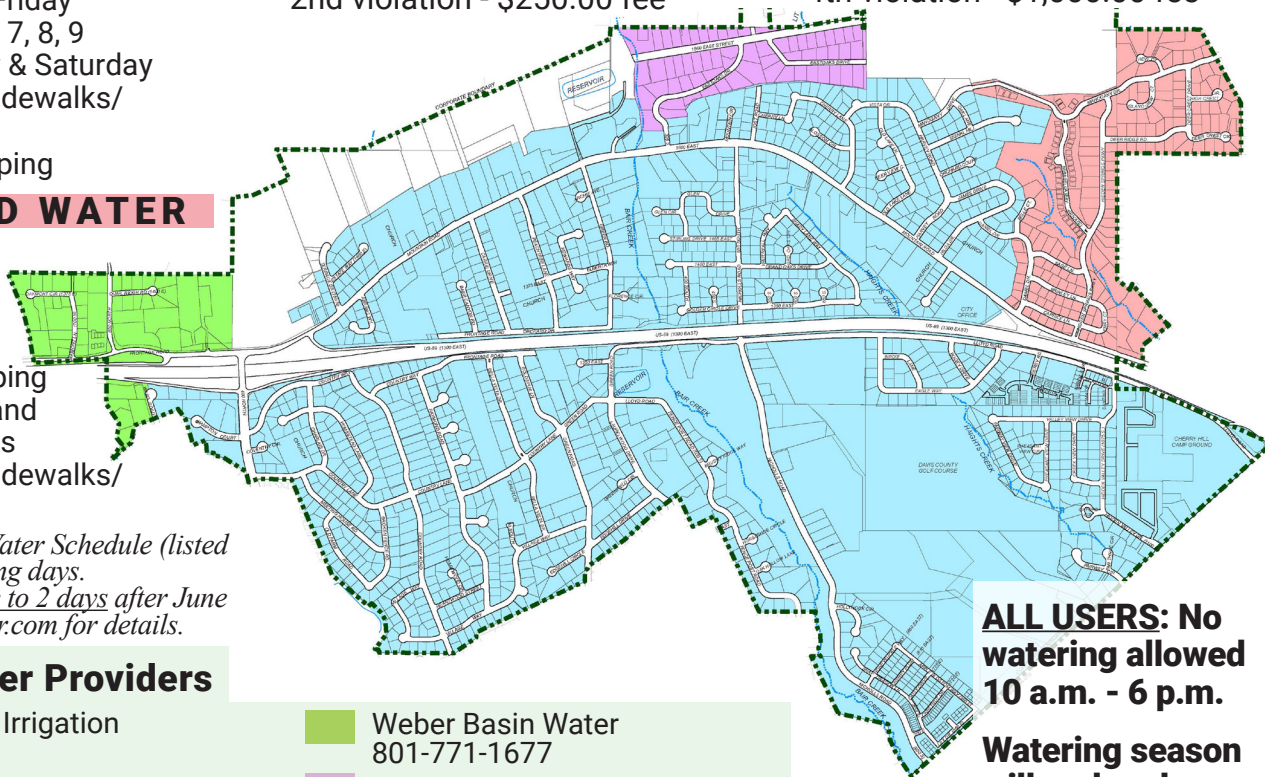
3rd violation - \$500.00 fee

4th violation - \$1,000.00 fee

2. Water based on home address:
 - Address ending in even # irrigate Monday, Thursday
 - Address ending in odd # irrigate Tuesday, Friday
3. No hosing down sidewalks/driveways
4. Limit new landscaping
5. Violation fees
 - 1st violation - Given notice
 - 2nd violation - \$250.00 fee
 - 3rd violation - \$500.00 fee
 - 4th violation - \$1,000.00 fee

WILDFIRE AWARENESS

Concern about wildfires is high again this year due to continued drought conditions. Much of our city is surrounded by thick vegetation which is drier than usual, causing extreme fire dangers in this area.

These dangers create the need for restrictions regarding open fires and fireworks in our city. Only a limited number of areas allow for the discharging of fireworks within Fruit Heights. The City Council will review, and may amend, current firework restrictions and maps at a **City Council meeting on June 7**.

Fires are never allowed in canyons or along trails. These areas are on Forest Service Land. Open burning is NOT ALLOWED in residential areas unless land is zoned for agricultural use. **See the Open Burn and Fireworks Restrictions map at www.fruitheightscity.com.**

NEW WATER ORDINANCES WILL BRING "FLIP YOUR STRIP" TO FRUIT HEIGHTS



Recently, members of the Fruit Heights City Council updated water efficiency landscaping ordinances. These updates will be

presented at the **Planning Commission Meeting on June 21**. If approved, the Weber Basin Water Conservancy District can then offer the Flip Your Strip incentive program to residents of Fruit Heights.

CONSTRUCTION UPDATE

Quail Ridge Drive: Wardell Brothers Construction was awarded the reconstruction project of Quail Ridge Drive and 650 N. Work will include the installation of a new culinary water line, a new secondary water line, a new storm drain line, and new curb and gutter. When underground work is complete, the City will repave 650 N. and Quail Ridge Drive with new asphalt. It is expected this project will begin around mid-June.

Nicholls Road: Wardell Brothers was awarded the contract to install new curb and gutter along the south side of Nicholls Road between 1200 E. and 1240 E. Work is anticipated to begin in late summer or early fall.

Cherry Lane: Skyview Excavating was awarded the contract to replace aging culinary water lines in two areas of the city. Around June 15th, Skyview will begin work at 1576 E. Cherry Lane, and extend around the entire length of Cherry Lane to Jost Road. The culinary water line located in Jost Road will also be replaced at this time. It is anticipated the project will be completed by mid-to-late fall. The contract requires work be complete before the weather turns cold for the season.

Mountain Road: Weber Basin Water Conservancy District continues work to replace their aging water line in Mountain Road. It is anticipated this project will be completed by late summer.

More than 150 residents switched last month. Thanks!
